- **Finance Report for August 2017 – BUDGET REPORT** Lines 4: Updated student numbers. Lines 27, and 28: Will not have positions this year. Lines 30: Revenue increase by 77.9K. Lines 136-137: Increase service. Lines 147: Revised services. Lines 171: Budget balance increase by 4.1K. Lines 177 and 178: New line items. Lines 180: Revised. Lines 181: New line item. Lines 182: Fund Balance increased by \$314.1K.
- Laura Blackmore reviewed the August finance reports in Mr. Moser's absence. The Chair called for the Board's approval of the August financials. Eunice Spilliards made a motion to approve the August financials as presented and Kelli Boniecki seconded the motion, which carried unanimously.

**Update on New Campus Financing** – The draft appraisal has been sent to the regional USDA office for feedback from Rusty Craven, after which it will be finalized before going to state office. When it is completed, the feasibility study will go with the appraisal. RLOA will await feedback from the USDA regarding the bids and other contractual matters.

## **School Updates**

- **Enrollment:** Current enrollment for 2017-18 SY is 661. There is a current waitlist of 167 students with the highest for middle and high school grades. The goal was enrollment of 650 students.
- Dr. Wicks noted the school suffered no damage from Hurricane Irma.
- The cleanup of surrounding abandoned buildings is ongoing.

- Executive Director's Report-** Dr. Wicks noted that the 3 days of no school due to Hurricane Irma will be made up on Nov. 3<sup>rd</sup>, 10<sup>th</sup> and Dec. 1<sup>st</sup>.

Dr. Wicks reviewed MAP testing scores that took place prior to departure for the hurricane. Data is currently being reviewed.
